FIRST CALL – NOTES FROM THE FRONT

HAPPY WHATEVER, I HOPE?

It's hard to come up with an appropriate greeting for all our service members, veterans, and their families and supporters at this holiday season. It is certainly hard to come up with a cheerful one.

Whether it is Hanukah, Christmas, Ramadan, Lohri, Kwanzaa, Festivus – whatever – there just doesn't seem to be any catchy phrase that can make things feel much better for those who are bearing the burden of the current wars, or the burden of wars long fought.

So, with everyone else blaring the "Spirit of the Season" and "Comfort and Joy", I am going to indulge in a little "Bah Humbug!"

Nothing seems to be getting better, unless these count:

- We are getting out of Iraq – someday soon (we still have 120,000 soldiers there).
- And we are finally getting serious about Afghanistan (we have 100,000 there or will have very soon).
- We are reducing the use of contractor's in military jobs in Iraq (but increasing them in Afghanistan).
- We are making our enlistment goals (by lowering the goal post each year).
- Unemployment has "dropped" to 10% (no jobs for returning veterans).
- Foreclosures are down among the bankers and brokers – they're up for the rest of us (hope your home is there when you get back).

Just today I read a letter from a serving field grade officer who stated (I paraphrase) "There is nothing at all wrong with our Army. We can take care of any and all military tasks, anywhere in the world, all the time."

Makes you wonder if you want your kids and grandkids to be led by someone who is so out of touch with reality, doesn't it? Ask yourself if today's Army and Marine Corps could take on another 100,000-person deployment right now.

Absolute realism is the first task of military leadership.

I understand his need to defend his service, but the truth is that our military ground forces – Army and Marines – is stretched to the breaking point. While the current deployment scheme is exhausting the active force, the continuing overuse of the Guard and Reserve is destroying the bench.

Nothing in any calculation is including the real cost of supporting returning veterans, some of them for life.

While good laws favoring veterans are on the books – USERRA is an example – no one is enforcing them.

We have to stop and praise those companies like Sears who really go beyond the requirements of USERRA and protect the jobs, pay the differences in salaries, and continue families on medical benefits while their employees are called up in the Guard and Reserve. Sears is not alone in this, but they are better than most. There are still precious few companies who step up.

Almost nothing is improving in the administrative side of the VA even though the medical side is among the finest in the world. All that good care is no good if you can't get into the system. Today's VA epitomizes the real difference between the much-touted "availability" and real "access".

I have stated in these pages before that I support (reluctantly) the actions that are finally being taken in

Afghanistan. I believe that had we taken today's course in 2002, all of our troops would have been home a long time ago, including many who will never come home again.

There is a lesson to be learned from war, but it is one that we seem to forget every time. Wars cost, and the cost is tallied in much more than money.

How do we place a value on lives and families destroyed? How do we value the hatred we generate when we undertake aggressive and unnecessary wars? How do we put a price on the opportunity costs – the tasks left undone or delayed because we are spending our wealth on war?

Most of all, whatever the cost, why is the burden borne by so few?

Just this week some US Senators decided that in order to get their way on the health care bill they would filibuster the defense authorization bill which was already three months overdue. Does Congress have any idea what message this sends to the troops?

The message I take from it is that the funding of our soldiers is a useful pawn to gain political or ideological advantage in political fights that have nothing to do with the war or with them. The further message is that the plight of our soldiers is nowhere near as important as winning some Congressional skirmish for power.

Shame on them, whatever party they belong to. What part of the burden of today's wars are they bearing personally? Are they serving? Are their sons and daughters or grandsons and granddaughters serving?

Are they paying more taxes? Are they even donating blood?

Of course they are not alone. We have spent almost a trillion dollars on these wars but have your taxes risen? Have you been asked to forego any pleasure – any personal gratification? Are you devoting your time and your money to veterans issues? Have you contacted your Congressperson and demanded that they get things in hand?

No – we are almost as disengaged as the Congress (although not quite – no one could be that disengaged).

I must not be too harsh on everyone. I see in this morning's news that some tycoons are making a real sacrifice. The head of Disney will forego 5% of his annual salary and take home only \$29M this year. That's the way to sacrifice!

The public is so concerned about what is happening to our soldiers that they routinely shell out \$150M to see the latest frat-boy comedy, but can only work up a little over \$12M to see "Hurt Locker", the story of the EOD specialists in Iraq. It's not that they hate violence; they shelled out twice as much to see "Saw IV".

So I'll close with my personal wish – not bound by any religious holiday – that all of our brothers and sisters in Iraq and Afghanistan, and those committed to go under new deployments – come home safely, and very soon.

As for the rest of America, or at least the largest portion of it with special attention to Congress – here's coal in your stocking.

RECALL - FEDERAL AND STATE LEGISLATION AND LEGISLATORS

CONGRESS DIRECTS DEFENSE AND VA TO CONSIDER COMMON HEALTH IT SYSTEMS

In a report accompanying the final version of the fiscal 2010 Defense Appropriations bill, lawmakers recommended that the Defense and Veterans Affairs departments develop common medical information technology systems to handle laboratory work, pharmacy orders, patient scheduling and transmission of digital radiology images.

While Defense and VA have taken steps to modernize their health IT systems and address interoperability problems, "it appears that both departments are not sufficiently coordinating their efforts, and that lessons learned are not being used to develop an efficient and cost-effective means for data interoperability and information technology modernization," the [report](#) stated. President Obama signed the Defense spending bill on Monday.

Lawmakers acknowledged that Defense and VA have unique IT system requirements, but noted the departments also have common needs that should result in the development of common technology solutions and architecture.

REP. FILNER'S H.R.2254 NEEDS ADDITIONAL COSPONSORS TO SUPPORT VIETNAM VETS

A bill, H.R.2254, introduced by the Chairman of the House Veterans Affairs Committee, Rep. Bob Filner (D-Calif) needs additional cosponsors to ensure release from the Subcommittee on Disability Assistance and Memorial Affairs. The legislation would amend title 38, United States Code, to clarify presumptions relating to the exposure of certain veterans who served in the vicinity of the Republic of Vietnam and include Vietnam veterans who served in Thailand and off the Vietnam shore who may have been exposed to Agent Orange.

Currently, VA requires Vietnam veterans to prove "foot on land" in order to qualify for the presumptions of service-connection for herbicide-exposure related illnesses afforded under current law. This issue has been the subject of much litigation and on May 8, 2008, the Federal Circuit Court of Appeals upheld VA's overly narrow interpretation. Congress clearly did not intend to exclude these veterans from compensation based on arbitrary geographic line drawing by VA.

"We owe it to our veterans to fulfill the promises made to them as a result of their service," said Chairman Filner (D-CA). "If, as a result of service, a veteran was exposed to Agent Orange and it has resulted in failing health, this country has a moral obligation to care for each veteran the way we promised we would. And as a country at war, we must prove that we will be there for all of our veterans, no matter when they serve. The courts have turned their backs on our veterans, but I believe this Congress will not allow our veterans to be cheated of their earned benefits."

H.R. 2254 would amend title 38, United States Code, relating to presumptions of exposure for veterans who served in the vicinity of Vietnam. As introduced, Filner's bill would do away with the VA's rule of "boots on the ground" in Vietnam to receive presumptive status for exposure to Agent Orange, and include the "Blue Water Navy" and airman who served in Thailand and Guam.

Currently 226 Representatives have co-sponsored the bill.

REPORT: OBAMA NOW AIMS TO CLOSE GUANTANAMO BY 2011

President Barack Obama's ambitious plan to shut down the Guantanamo Bay prison facility by 2010 was dealt a major blow when lawmakers refused to earmark funds in a military spending bill Congress approved last week that would have allowed the federal government to purchase a near-empty maximum security prison in Illinois to house some detainees.

As a result, Guantanamo will not be shut down until 2011 at the earliest, according to a [report](#) published Wednesday in the New York Times. Obama had hoped to close the detention center by January 22, 2010 but he acknowledged in November he would miss that deadline, which he set shortly after being sworn in as president. <More at: <http://www.truthout.org/1224092>>

Anyone who becomes pregnant or impregnates another servicemember, including married couples assigned to the same unit, could face a court-martial and jail time, according to an order issued by Maj. Gen. Anthony Cucolo.

ARMY GENERAL WHO IMPLEMENTED PREGNANCY POLICY RESPONDS [TO CRITICISM]

The Army general commanding US military personnel in northern Iraq who implemented a controversial policy last month that said female soldiers who become pregnant, and the men who impregnate them, could be court-martialed and sent to prison issued a lengthy response to Truthout explaining his order following the publication of our report on the matter Monday.

In an email, Maj. Gen. Tony Cucolo said he appreciates "the discussion about one aspect of a general order I have applied here in the combat zone of Iraq. The true intent of my directive cannot be easily understood from one or two brief articles, so I would like to clarify my rationale for the directive."

Cucolo added:

In this 22,000 Soldier Task Force, I need every Soldier I've got, especially since we are facing a drawdown of forces during our mission. Anyone who leaves this fight earlier than the expected 12-month deployment creates a burden on their teammates. Anyone who leaves this fight early because they made a personal choice that changed their medical status -- or contributes to doing that to another -- is not in keeping with a key element of our ethos, "I will always place the mission first," or three of our seven core values: loyalty, duty and selfless service. MILITARY TO DROP BAN ON SOLDIERS GETTING PREGNANT IN IRAQ

The controversial order banning pregnancy among troops serving in northern Iraq will cease to exist on Jan. 1 when forces throughout the country begin operating under a new, unified set of regulations, an Army official said Thursday.

With the transformation from Multi-National Force-Iraq to United States Forces-Iraq, Gen. Ray Odierno, the top U.S. commander in the country, is issuing a comprehensive General Order No. 1, according Lt. Col. Josslyn Aberle, spokeswoman for Odierno.

It will draw from various orders previously in place but leave out the pregnancy ban enacted in November by Maj. Gen. Anthony Cucolo.

The decision to exclude the ban comes less than a week after Stars and Stripes reported on its existence. The policy, which leaves open the possibility of court-martial and jail time for soldiers getting pregnant or impregnating another soldier, drew sharp criticism, with opponents saying it infringed on basic rights of the individual.

STUNNING STATISTICS ABOUT THE WAR EVERY AMERICAN SHOULD KNOW

A hearing in Sen. Claire McCaskill's Contract Oversight subcommittee on contracting in Afghanistan has highlighted some important statistics that provide a window into the extent to which the Obama administration has picked up the Bush-era war privatization baton and sprinted with it. Overall, contractors now comprise a whopping 69% of the Department of Defense's total workforce, "the highest ratio of contractors to military personnel in US history." That's not in one war zone—that's the Pentagon in its entirety.

In Afghanistan, the Obama administration blows the Bush administration out of the privatized water. According to a [memo](#) released by McCaskill's staff, "From June 2009 to September 2009, there was a 40% increase in Defense Department contractors in Afghanistan. During the same period, the number of armed private security contractors working for the Defense Department in Afghanistan doubled, increasing from approximately 5,000 to more than 10,000."

At present, there are 104,000 Department of Defense contractors in Afghanistan. According to a report this week from the Congressional Research Service, as a result of the coming surge of 30,000 troops in Afghanistan, there may be up to 56,000 additional contractors deployed. But here is another group of contractors that often goes unmentioned: 3,600 State Department contractors and 14,000 USAID contractors. That means that the current total US force in Afghanistan is approximately 189,000 personnel (68,000 US troops and 121,000 contractors). And remember, that's right now. And that, according to McCaskill, is a conservative estimate. A year from now, we will likely see more than 220,000 US-funded personnel on the ground in Afghanistan. <More at: <http://www.truthout.org/1218098>>

VOTE TO DELAY FUNDING FOR TROOPS -- AS PART OF HEALTH CARE DEBATE?

Everybody knows the health care debate has become more and more contentious, and dominated by a Republican parliamentary effort to delay the debate. But an under-appreciated aspect of this whole controversy -- exceedingly rare, if not unprecedented -- is the fact that it's even affected *defense spending*, with Senate Republicans having worked to hold that up, too! Late on Thursday night, the Senate voted 63-33 to break a Republican filibuster of the defense appropriations bill. Only three Republicans voted against this delay of military spending: Kay Bailey Hutchison (TX), Olympia Snowe (ME) and Susan Collins (ME). The filibuster was part of a Republican effort to further delay the health care bill.

AFTER SEVEN YEARS THIS IS STILL GOING ON?

LAWMAKERS: SOLDIERS HAVE PROBLEMS WITH COMBAT GEAR

WASHINGTON (AP) -- Troops are being sent to war zones without proper training and suitable gear, according to two senior Democratic lawmakers who say they've been told by soldiers about problems ranging from their backpacks to their rifles.

In a Dec. 10 letter to the Pentagon's top leaders, Rep. Ike Skelton, chairman of the House Armed Services Committee, and Rep. Solomon Ortiz, who heads the subcommittee on military readiness, said they are "greatly troubled" by what they learned as the Obama White House begins escalating the U.S. presence in Afghanistan.

Adm. Mike Mullen, the chairman of the Joint Chiefs of Staff, has not seen the letter yet, according to Air Force Capt. Elizabeth Aptekar, a spokeswoman. "However, we appreciate the concern and the support the representatives have in our men and women in uniform and we will look into this matter," she said.

Soldiers are being issued a rucksack made of plastic that is not comfortable or effective in combat situations, Skelton and Ortiz found during a recent trip to Germany and Italy where they met with members of the 503rd Infantry Regiment and the 173rd Airborne Brigade Combat Team.

Troops carry heavy loads on their backs and the plastic straps cut off circulation to their hands and arms, "making it virtually impossible to fire their weapons," they told Mullen and Defense Secretary Robert Gates.

Skelton and Ortiz said many of the soldiers they talked to are using their own money to buy better packs from commercial suppliers.

The M4 carbine, a shorter, lighter version of the M16 rifle, was also criticized. Skelton and Ortiz said they've had long-standing concerns with the M4. Those worries mounted after a study by a military historian found the rifle failed at critical moments during a July 2008 firefight in Afghanistan that left nine U.S. soldiers dead.

"Even though these weapons routinely rank lower than other military weapons in testing, they are still being issued as the Army's weapon of choice," the letter says. <More at: http://www.breitbart.com/article.php?id=D9CK283G0&show_article=1>

NAVY: INVESTIGATION DROVE SAILOR TO SUICIDE

A Navy investigation of a sailor's suicide in Bahrain in 2007 concluded that she was driven to kill herself by an earlier investigation into allegations of hazing in the dog-handling unit she headed for several months.

Petty Officer 1st Class Jennifer Valdivia had been told she might be disciplined for not reporting the wrongdoing, which included sailors being force-fed dog treats, hog-tied to chairs, locked into a feces-filled kennel and ordered to simulate homosexual oral sex in training videos.

One of her superiors cautioned the officer in charge that more senior personnel needed to be held accountable as well.

Valdivia "felt she was being made a scapegoat," the investigator wrote, adding that "her final act revealed her to be under stress she was not able to bear. ... I believe it is unlikely she would have committed suicide if she had not been under such stress."

... Valdivia's predecessor as kennel master, Chief Petty Officer Michael Toussaint, whom several former members of the unit now blame for masterminding the abuses, received a non-punitive letter, which is not entered into any official record, and was promoted to senior chief.

Three months ago, after details of the abuses became public, the Navy took a new look at the case. As a result, Toussaint received a letter of censure from Navy Secretary Ray Mabus and will be forced into early retirement next month.

CREMATED REMAINS DUMPED IN ARLINGTON LANDFILL

Records at Arlington National Cemetery suggest that workers found an urn of cremated remains that had been dumped -- presumably accidentally -- in a dirt landfill, reburied those remains as an unknown soldier, and kept the whole thing quiet.

With the publication of this article, Salon has now disclosed four separate cases in which the cemetery discovered unmarked remains due to burial glitches, mostly poor record-keeping. In a fifth case, the cemetery accidentally buried the remains of one service member on top of another in the same grave. VETERANS FIND PEACE WORKING ON SAN DIEGO-AREA FARM

VALLEY CENTER, Calif. (AP) -- When Carlos Rivera returned from fighting in Iraq and found work as an electrician, he felt co-workers who knew about his military experience were gawking at him. He went home angry each day.

That's not a problem at his current job working alongside other combat veterans picking avocados, mixing organic fertilizers and gathering basil amid northern San Diego County's undulating ochre hills.

"I'm outdoors, not stuck inside somewhere feeling suffocated," said Rivera, 25, who returned from Iraq in 2007 after four years as a Marine. "There's always someone to talk to, someone there to understand."

Rivera works at Archi's Acres, a 3-acre high-tech organic farm owned by Colin Archipley, who served three tours in Iraq and is trying to help other combat vets shake the trauma of war by turning swords to plowshares.

U.S. DROPS LAWSUIT AGAINST PROTESTING VETERANS

A group of elderly veterans had been hanging the U.S. flag upside down on a federally owned fence outside the Brentwood VA. The 'distress symbol' was a way of protesting commercial uses of VA land.

Federal officials seem to have waved the white flag in their battle with a group of elderly former servicemen who fly the American flag upside down as a "distress symbol" to protest commercial activities at the VA's Brentwood medical center.

The Department of Veterans Affairs last week dropped charges against Robert Rosebrock alleging that he and other former military men desecrated the U.S. flag by hanging it upside down on a fence outside the agency's Wilshire Boulevard property.

The VA requested the dismissal days after the American Civil Liberties Union agreed to help fight the charges.

The ACLU stepped in against Raab's group and their Veterans Affairs partners when political fixers tried to stop protesting vets. Charges against veterans protesting Raab's project, said to be a "con" meant to keep homeless vets away from the wealthy elite, were dropped when the ACLU announced its support for protesting veterans supported by the American Legion and other groups.

With General Shensiki, head of the Department of Veterans Affairs, calling homelessness among veterans a national disgrace [see related story below], the Raab project to take land designated for veterans housing and build a "contemplative garden" has an odd ring about it. Washington » Nobody wants to buy them a beer.

Even near military bases, female veterans who served in Iraq and Afghanistan aren't often offered a drink on the house as a welcome home.

More than 230,000 American women have fought in those recent wars and at least 120 have died doing so, yet the public still doesn't completely understand their contributions on the modern battlefield.

For some, it's a lonely transition as they struggle to find their place.

Aimee Sherrod, an Air Force veteran who did three war tours, said years went by when she didn't tell people she was a veteran. After facing sexual harassment during two tours and mortar attacks in Iraq, the 29-year-old mother of two from Bells, Tenn., was medically discharged in 2005 with post-traumatic stress disorder.

VA SUMMIT FRAMES PLAN TO END VETERAN HOMELESSNESS

WASHINGTON, D.C. – The U.S. Department of Veterans Affairs (VA) held a historic three-day conference in the nation's capital last week to signal the beginning of a new mission for the agency – to end veteran homelessness in five years.

More than 1,300 VA clinicians and health care specialists, representatives of federal agencies invested in providing support for homeless and low-income veterans, and community- and faith-based service providers represented by the National Coalition for Homeless Veterans (NCHV) assembled to provide input on strategies that will shape the VA's five-year plan.

"My name is Shinseki, and I am here to end veteran homelessness," said VA Secretary Eric Shinseki in his opening address. "Many of you have been working the issue of veteran homelessness for a long time. ... I'm the newcomer here today, so let me reiterate that this is not a summit on homeless veterans – it's a summit to end homelessness among veterans. That's our purpose.

"President Obama and I are personally committed to ending homelessness among veterans within the next five years. I learned long ago that there are never any absolutes in life, and a goal of zero homeless veterans sure sounds like an absolute. But unless we set ambitious targets for ourselves, we would not be giving this our very best efforts. No one who has served this nation as veterans have should ever be living on the streets."

WOMEN SOLDIERS FORCED TO RESORT TO BACK-ALLEY ABORTIONS: WHY ARE THEIR REPRODUCTIVE RIGHTS DENIED?

"You hear these legends of coat-hanger abortions," a 26-year-old former Marine sergeant told me recently, "but there are no coat hangers in Iraq. I looked." Amy (who prefers not to use her real name) was stationed in Fallujah as a military journalist two years ago when she discovered she was pregnant. As a female Marine, a distinct minority in the branch, Amy was fearful of going to her chain of command to explain her situation.

For military women, who lack all rights to medical privacy, facing an unplanned pregnancy is a daunting obstacle. Thanks to anti-abortion forces in Congress, military hospitals are banned from providing abortion services, except in cases of life endangerment, rape, or incest (and for the latter two, only if the patient pays for the service herself). Amy says her options were "like being given a choice between swimming in a pond full of crocodiles or piranhas."

SEX ASSAULT REPORTS PLUMMET AT AIR FORCE ACADEMY

DENVER — Reports of sexual assaults at the Air Force Academy dropped by two-thirds in the 2008-2009 school year, but it's not clear whether the number of attacks declined or fewer victims came forward, officials said Friday.

Eight assaults were reported in the year that ended in May 2009, compared with 24 the year before, the Defense Department said in its annual report on assaults and harassment at U.S. military academies.

"We're not quite sure we know how to characterize the decline, but we know we want to keep the heat up on our program," said Air Force Col. Gail Colvin, the academy's vice commandant of cadets for culture and climate.

The Pentagon study says the decline could reflect the fact that the number of assaults has decreased or it could indicate that not all assaults were reported for various reasons.

DOD BLINKS: BURN PITS TIED TO ILLNESS

SALT LAKE CITY, Utah -- Backing away from steadfast official denial, the U.S. military's senior health protection official said Monday that some service members might suffer long-term medical problems as a direct result of exposure to smoke and fumes from open-air burn pits scattered throughout Iraq and Afghanistan.

Physician Craig Postlewaite, director of Force Health Protection and Readiness Programs, said that while scientific evidence has yet to prove the link, the personal stories of veterans coming forward to report long-term health problems have convinced him of the connection.

"We feel at this point in time that it's quite plausible -- in fact likely -- that there are a small number of people that have been affected with longer-term health problems," Postlewaite said Monday.

A NEW LIFE NURSING THEIR DAMAGED WARRIORS

The two soldiers lolled speechless in wheelchairs, severely brain damaged by war, staring out at the home front from a diagnosis of "minimal consciousness." Their young brides fed them through gastric tubes, one of the frequent tasks in the women's brave new careers as veterans' family caretakers.

It is a sweet and bitter fact of modern battlefield medicine that more warriors can survive devastating brain wounds that would have killed them in previous wars.

There are about 2,000 suffering the most severe brain trauma from Iraq and Afghanistan, with perhaps 200 more a year to come, according to an estimate by the Wounded Warrior Project, a charity that helps damaged military families.

Rather than store away these young men and women in nursing homes, more family members — their own lives forever upended — are opting to be trained to nurse and rehabilitate their loved ones at home. These gritty families insist that a home setting is essential to any recovery and hope of a worthwhile lifetime.

"I chose to stay with my man," explained RyAnne Noss, ministering to her husband Scot, a once powerful Army Ranger who was dragged from a helicopter crash in Afghanistan. RyAnne put aside her Ph.D. in chemistry to become Scot's round-the-clock helpmate rather than leave him for visits across years in a convalescent home.

DOVER - Gary Forst moved into the Veterans Home at Union Grove about four years ago. Soon after, Harold Yonker moved in too. The two men, veterans of different wars, have been friends ever since they moved into Gates Hall, one of the assisted living facilities on the Union Grove campus.

It won't be long before Yonker, 87, moves out. At least he hopes to. That's been his plan ever since he and his fellow residents learned in November that the Department of Veterans Affairs will increase their rent by as much as 37 percent.

The rate hike takes effect Jan. 1. That's when the daily rate of \$83 jumps to a little more than \$114 per day, at least for Yonker. That's an increase of nearly \$930 each month. The rates vary for different residents, depending on the level of care they need. A WARRIOR PASSES IN TEXAS

Retired Army Col. Robert L. Howard, a Medal of Honor recipient for combat action in Vietnam in 1968 and one of the America's most highly decorated Soldiers, died Dec. 23 in Waco, Texas.

The 70-year-old Howard died in a hospice in Waco, according to a report in the San Antonio Express News today. The paper, quoting a longtime friend of Howard's, retired Sgt. Maj. Benito Guerrero, said Howard had been suffering from pancreatic cancer.

Howard began his Army career as an enlisted man. During one 13-month tour in Vietnam he was nominated for the Medal of Honor three times, but in the first instance the award was downgraded to the Distinguished Service Cross. Several biographies say that downgrade, as well as another -- to the Silver Star -- was to avoid the problem of noting in the Medal of Honor citation specifics of the combat operations, which were covert.

NATIONAL GUARD AND RESERVE ACTIVATED AS OF DECEMBER 22, 2009

This week, the Air Force and Coast Guard announced an increase in activated reservists, while the Army, Navy, and Marine Corps announced decreases. The net collective result is 620 fewer reservists activated than last week. At any given time, services may activate some units and individuals while deactivating others, making it possible for these figures to either increase or decrease. The total number currently on active duty from the Army National Guard and Army Reserve is 105,885; Navy Reserve, 6,266; Air National Guard and Air Force Reserve, 15,298; Marine Corps Reserve, 7,593; and the Coast Guard Reserve, 779. This brings the total National Guard and Reserve personnel who have been activated to 135,821, including both units and individual augmentees. I also favor articles that deal with the effect of Legislative or Executive inaction or bad actions that adversely affect our target group. I try not to pick those articles that have already been beaten to death in the regular press, but rather try to bring the reader articles that he or she might not run across in another medium. While we are non-partisan, I do not believe articles critical of government actions to be partisan as long as they are accurate and fair. Criticism, like dissent, is fair. Finally, I screen hundreds of articles for inclusions and for every article I include, I throw five or six away – good articles, but not as important as the ones selected.

I always appreciate contributions, whether it is opinion in Letter-to-the-Editor form, or articles that the reader believes would be good for our readership. Since I get a chance to vent once in awhile in these newsletters, I will certainly consider Op-Ed copy for inclusion. I always welcome reader comment or complaint. [Sandy Cook](#), Editor
