#### FIRST CALL - NOTES FROM THE FRONT

#### **OF HEROES AND COWARDS**

True heroes, like perfect diamonds, are rare. I, for one, get tired of non-participants continually referring to every soldier as a "hero". It cheapens the term, and embarrasses the soldiers – they know better..

That is not to say that we don't need more heroes. We always do, but we need them in many more endeavors other than war.

The obvious places are in the ranks of first responders, where there are normally at least as many true heroes as there are in military uniform. There are also heroes in the giving professions such as those doctors and nurses who give of their time and energy and knowledge in many organizations such as Doctors Without Borders and the International Red Cross, often in places of great danger, and without any real hope of reward.

Some less obvious homes for heroes are in the silent background of legislation and litigation when true heroes take on the mighty for the good of the ignored and the dismissed, which usually means for the good of us all.

Heroes such as these – true heroes – are what makes life so rewarding for many of us without our even having to turn a hand. They do it for us – every day. They set an example for us which most of us cannot hope to equal it, but we can marvel at the capability of the truly heroic human soul. Why, then, are there so many cowards? How do we happen to raise up so many who will never risk their personal comfort, position, or hope for power? Why do we make them the heads of corporations, banks, and other institutions. Why do we lionize them for their selfishness and their "successes" as they often rob us blind, while we ignore those who truly strive for us every day?

Why do we allow them to present themselves as heroes?

Why do we elect so damn many of them to public office?

The party out of power can never get anything done because they are afraid to lose – cowards quit; heroes lose and lose again but keep on fighting.

The party in power can never get anything done because the other party blocks their selflabeled "heroic" efforts.

The real reasons for both conditions and both parties are usually [pick as many as apply to your legislator] a) their contributors won't like the results; b) they are afraid that their constituents won't re-elect them; c) they are committed to some ideology that pre-selects their vote; d) they just want to laze around in the backwaters of power, get the perks, and not be disturbed; e) they'd rather do nothing than expose their incompetence; f) they really don't care about now – it's the revolving-door job

they are going to get next that must be protected.

Our current crop have become a class of cowards, with a very few notable exceptions on both sides. More than that, they have become almost a separate ruling class. Every time one of them starts a declaration with "The American people want/need/demand/…" I cringe. What do they know about all of us? All they know is that we are a source of votes and of tax money that funds their perks, and pays for the pork they feed to their districts to ensure the next round of contributions and their guaranteed reelection.

It's not just politicians. Why do we hire so many cowards as public servants?

As a prime example, the Department of Veterans Affairs has just let two senior executives go who failed over nine years to implement a computerized scheduling system for veterans' appointments, while spending \$167M. Incompetence, yes, but cowardice also. If they couldn't do the job with the resources they had or the contract they were stuck with, they should have stood up and said so. Instead they wallowed in their cowardice and incompetence, hoping never to be discovered (at least until retirement).

What's the effect of all of this on the people we care about; serving military, veterans and their families?

The politicians and the bureaucrats know that if we had universal health care, as most other developed nations do, we could eliminate the DVA's backlog for normal medical services almost overnight. If we had universal health care we would make our industries and our industrial communities more competitive for both the goods we sell and the jobs we all, including veterans, seek. But in the face of the health insurance and pharmaceutical industry's deep well of contributions, these cowards are unable to see a solution. They cannot cough up enough courage to take on that wealthy bunch of contributors.

The politicians and the bureaucrats know that there is only so much money to fund the Armed Forces, although that number is obscenely large in the face of the amount spent in the rest of the world. Because there are nonetheless limitations on what is available, they know that the money for defense must be spent wisely, and on those items that address the real threat to those who are in action or who may be called upon to fight. Yet they are unable to muster the courage to face the hard choices, preferring to continue expensive programs because of their immediate effect on their reelection possibilities (think F-22), rather than choosing the hard road that would lead to the programs and systems that the troops really need.

Our legislative cowards claim that it is only because of the jobs that they continue to support what, in the case of the F-22s, may be the largest and most expensive fleet of hangar queens ever built. But the same money could provide jobs in many more places – teachers, construction workers, planners, engineers, transportation workers. It's not jobs – its cowardice – an unwillingness to make the hard choices. <u>See what's happening as we speak.</u>

The politicians and the bureaucrats know that when they send someone into battle, or merely enlist that person for the possibility of future battle, they make a commitment to that woman or man that is far different from the normal employment contract. That difference costs money – perhaps for a lifetime – but they do not have the courage to calculate the full cost of an individual's service, and especially the full and true cost of wars in their decisions. Instead they hide from that responsibility and muddle along, stripping our national treasure in what they hope is small enough increments that no one notices. They consistently underfund veterans services and the personal and family services for the serving military. They hide when the subject of inadequate

funding and unconscionable delays come up, all the time trumpeting their "support of the troops". (Can't we find another expression? That one is slimed with hypocrisy.)

So let's limit the set of those we call heroes to those who have the courage to do their jobs without thought of personal gain, who serve all of us probably far better than we deserve, who face real personal or professional danger and conquer it, and who do not even demand of us that we recognize their heroism, only demanding that we honor their service.

And let's call out the cowards for who they are. Let's get right with the heroes of the past and the hopes of the future by pegging these cowards publicly, demanding that they step up to their job, which is to serve us and not them.

Remind them that there are 24 million veterans out here and we vote, as do our families.

Tell them to fight for what is right, not what is convenient and comfortable, and if they lose, step up and fight again! If they are not willing, tell them that we veterans will find someone who is.

After he returned to his home in Contra Costa county he spent much of his remaining years as a lawyer fighting for farm-workers' rights

#### SENATE OKS NATIONAL SERVICE EXPANSION BILL

WASHINGTON, March 27 (UPI) -- The U.S. Senate passed a bill that would expand national community service, creating new groups of volunteers for education, energy, healthcare and veterans.

Senators voted 78-20 to pass the measure, named the Sen. Edward M. Kennedy Serve America Act to honor the Massachusetts Democrat and a key architect of the legislation, The New York Times (NYSE:NYT) reported Friday. </br>

# BILL SEEKS TO PROTECT GUN OWNERSHIP FOR VETS

Sens. Richard Burr, R-N.C., and Jim Webb, D-Va., have joined forces to try to prevent veterans from losing the right to own a gun if a fiduciary is appointed to handle their finances.

Burr and Webb, both members of the Senate Veterans' Affairs Committee, are trying to carve out a loophole for veterans in the Federal Gun Control Act that prohibits the sale of firearms to people who are, in the words of the law, "adjudicated as a mental defective."

According to Burr, the names of about 116,000 veterans have been turned over to the FBI since 1999 because the Veterans Affairs Department assigned a fiduciary to manage their benefits. #### HOUSE ADVANCES IMPORTANT VETERANS BILLS

Imperial Valley News - 30 March 2009

Washington, DC - Bob Filner (D-CA), Chairman of the House Committee on Veterans' Affairs, announced that the House of Representatives considered three bills that would improve benefits and services to veterans provided by the Department of Veterans Affairs (VA). The House unanimously passed all three bills.

H.R. 1377, as amended – To expand veteran eligibility for reimbursement by the Secretary of Veterans Affairs for emergency treatment furnished in a non-Department facility, and for other purposes (Introduced by Chairman Filner)

... H.R. 1171, as amended – Homeless Veterans Reintegration Program Reauthorization Act of 2009 (Introduced by Representative Boozman)

This bill would reauthorize the Homeless Veterans Reintegration Program for fiscal years 2010 through 2014. The bill was amended to authorize an additional \$10 million to provide dedicated services for homeless women veterans and homeless veterans with children.

... H.R. 1513 – Veterans' Compensation Cost-of-Living Adjustment Act of 2009 (Introduced by Representative Kirkpatrick)

#### DAVID SCHULTZ, DC REPORTER, HARASSED BY VETERAN AFFAIRS OFFICIAL

A troubling story has emerged this week regarding what many are calling unprovoked harassment and robbery of WAMU 88.5's David Schultz, an NPR-affiliate reporter, by a federal official at a Veterans Affairs Medical Center forum. The official -- an internal communications specialist named Gloria Hairston -- is said to have interrupted Schultz's interview with a veteran about the inadequacies of VA medical treatment. Hairston demanded that Schultz cease the interview and turn over all of his recording equipment. When Schultz refused, Hairston sicced armed police on him.

"She said I wouldn't be allowed to leave," Schultz tells WTOP.

At first he refused. But after being surrounded by armed police officers who stood between him and the exit, he looked for a compromise. "I became worried that I was going to get arrested," Schultz says.

Schultz convinced Hairston that all she really needed to confiscate was the memory card to his recorder, rather than all of his equipment. While this was going on, many of the veterans from the meeting had come out to watch the confrontation.

One of those veterans, an amputee in a wheelchair, approached Schultz and asked him for his phone number.

"I started to give it to him and then the woman {Hairston} became irate, she said you can't give him your phone number. You have to give me all of your equipment or I'm going to get ugly. She used the phrase 'get ugly,'" Schultz says. </br>

Testifying before the House Budget Committee, Robert F. Hale, undersecretary of defense-comptroller and chief financial officer at the Pentagon, noted that more jobs that had been done by government employees over the last decade are now outsourced to contractors.

"We need to look at how many contractors we are using and are there cost-effective ways we could do that in-house," Hale said.

President Obama has said he favors cutting back on the use of contractors. #### VA FUNERAL HOME ACCUSED OF ATROCIOUS CONDITIONS

WASHINGTON (AP) - A funeral home that helps handle veterans awaiting burial at Arlington National Cemetery left corpses in an unrefrigerated garage, hallways and on makeshift gurneys, according to a former embalmer who has given his photographs and notes to authorities, The Washington Post reported Sunday.

"It was disturbing and disrespectful and unethical," said Steven Napper, a retired Maryland trooper who worked at the funeral home for nine months. "I never could have imagined what I saw there or the things we were asked to do."

Napper said he saw as many as 200 corpses not properly cared for while working at National Funeral Home in Falls Church, Va., from May until he quit in February. # SHODDY WIRING 'EVERYWHERE' ON IRAQ BASES, ARMY INSPECTOR SAYS

WASHINGTON (CNN) -- Thousands of buildings at U.S. bases in Iraq and Afghanistan have such poorly installed wiring that American troops face life-threatening risks, a top inspector for the Army says.

"It was horrible -- some of the worst electrical work I've ever seen," said Jim Childs, a master electrician and the top civilian expert in an Army safety survey. Childs told CNN that "with the buildings the way they are, we're playing Russian roulette."

... Of the nearly 30,000 buildings the Army's "Task Force Safe" has examined so far, Childs said more than half "failed miserably." And 8,527 had such serious problems that inspectors gave them a "flash" warning, meaning repairs had to be completed in four hours or the facility evacuated. # VETERAN POSITIVE FOR HIV AFTER VA MISTAKE

A U.S. Department of Veterans Affairs patient has tested positive for HIV since being treated with equipment that exposed thousands of patients to other patients' body fluids.

The VA on Monday did not return telephone and e-mail messages seeking comment about the location of the medical facility where the patient was treated before testing positive for the virus that causes AIDS.

Five veterans have also tested positive for hepatitis B and 11 for hepatitis C since being exposed to equipment mistakes while getting colonoscopies at VA medical facilities at Murfreesboro, Tenn., and Miami and getting treatment at an ear, nose and throat clinic at Augusta, Ga.

#### VETS' HOMELESSNESS, MENTAL PROBLEMS EXPECTED TO LAST DECADES

NEW YORK — Homelessness, family strains and psychological problems among returning veterans of the Iraq and Afghanistan wars will persist in the United States for generations to come, the top U.S. military officer said Thursday.

"This is not a 10-year problem. It is a 50- or 60- or 70-year problem," Navy Adm. Mike Mullen, chairman of the Joint Chiefs of Staff, told an audience of the Hudson Union Society, a group that promotes non-partisan debate.

Mullen said he was particularly disturbed by the emergence of homelessness as a problem among war veterans.

"I have started to meet with, in veterans hospitals, homeless veterans" of the wars in Iraq and Afghanistan, he said. "And they are every bit as homeless and every bit as tragic as any homeless vet we've ever had. We as a country should not allow that to happen."

At a White House news conference last week, President Obama said some of the funding increases in his proposed budget for veterans affairs are directed at alleviating the problem of homelessness among veterans, which he said is a bigger problem, proportionally, than is homelessness in the rest of the American population.

#### ARMY VET BILLED \$3,000 FOR WAR WOUNDS

Erik Roberts, an Army sergeant who was wounded in Iraq, underwent his 13th surgery recently to save his right leg from amputation. Imagine his shock when he got a bill for \$3,000 for his treatment.

"I just thought it was bull---- that I'm getting billed for being wounded in Iraq doing my job. I always put the mission first, and now that I was wounded in Iraq, they're sending me bills," he said.

"I put my life on the line and I was wounded in combat, and I came back and they're not going to take care of my medical bills?"

It's a level of outrage shared by his mother, as well as the doctor who performed the surgery.

"It's hard to understand why we're not taking care of guys like Erik whose injuries are clearly related to their service. They deserve the best care of anybody," said Dr. William Obremskey, an Air Force veteran and surgeon at Vanderbilt Orthopaedics in Nashville, Tennessee.

"For him to be responsible for \$3,000, I think, is a little ridiculous or is uncalled for, particularly in this situation."

His mother, Robin Roberts, put it more succinctly: "Why should any soldier pay one penny of a medical bill from injuries that occurred while they were fighting in a war? That's what really frustrates me."

#### "I AM UNDER A LOT OF PRESSURE TO NOT DIAGNOSE PTSD"

A secret recording reveals the Army may be pushing its medical staff not to diagnose post-traumatic stress disorder. The Army and Senate have ignored the implications.

Editor's note: Last June, during a medical appointment, a patient named "Sgt. X" recorded an Army psychologist at Fort Carson, Colo., saying that he was under pressure not to diagnose combat veterans with post-traumatic stress disorder.

... For more than a year [Sgt. X] has been seeking treatment at Fort Carson for a brain injury and post-traumatic stress disorder, the signature injuries of the Iraq war. Sgt. X is also suffering through the Army's confusing disability payment system, handled by something called a medical evaluation board. The process of negotiating the system has been made harder by his war-damaged memory. Sgt. X's wife has to go with him to doctor's appointments so he'll remember what the doctor tells him.

... But what Sgt. X wants to tell a reporter about is one doctor's appointment at Fort Carson that his wife did not witness. When she couldn't accompany him to an appointment with psychologist Douglas McNinch last June, Sgt. X tucked a recording device into his pocket and set it on voice-activation so it would capture what the doctor said. Sgt. X had no idea that the little machine in his pocket was about to capture recorded evidence of something wounded soldiers and their advocates have long suspected -- that the military does not want Iraq veterans to be diagnosed with PTSD, a condition that obligates the military to provide expensive, intensive long-term care, including the possibility of lifetime disability payments.

... after the Army became aware of the tape, the Senate Armed Services Committee declined to investigate its implications, despite prodding from a senator who is not on the committee. The Army then conducted its own internal investigation -- and cleared itself of any wrongdoing.

#### **UNOPENED CLAIMS LETTERS HIDDEN AT VA OFFICES**

A new report about Veterans Affairs Department employees squirreling away tens of thousands of unopened letters related to benefits claims is sparking fresh concerns that veterans and their survivors are being cheated out of money.

VA officials acknowledge further credibility problems based on a new report of a previously undisclosed 2007 incident in which workers at a Detroit regional office turned in 16,000 pieces of unprocessed mail and 717 documents turned up in New York in December during amnesty periods in which workers were promised no one would be penalized.

"Veterans have lost trust in VA," Michael Walcoff, VA's under secretary for benefits, said at a hearing Tuesday. "That loss of trust is understandable, and winning back that trust will not be easy."

Unprocessed and unopened mail was just one problem in VA claims processing mentioned by Belinda Finn, VA's assistant inspector general for auditing, in testimony before the House Veterans' Affairs Committee. Auditors also found that the dates recorded for receiving claims, which in many cases determine the effective date for benefits payments, are wrong in many cases because of intentional and unintentional errors, Finn said.

#### VA CLAIMS -- DENY UNTIL THEY DIE?

The dead get faster service than the living these days at the Department of Veterans Affairs.

The VA took six months to grant World War II veteran Robert Dietrich of Bethlehem a disability pension. But even after that, it wouldn't pay right away, and Dietrich died before getting a cent.

The VA quickly acknowledged his passing, though, paying his life insurance proceeds in a month.

"If this is what these guys fighting today have to look forward to, oh my God," said his daughter, Monica Dietrich of Bethlehem.

The VA has long been criticized for delays in processing pensions and other benefits. Some veterans refer to the bureaucracy as "deny, deny, until they die."

... Monica Dietrich applied for a pension for him in February 2008. They got a foreboding form letter within a week acknowledging the claim.

"It is our sincere desire to decide your case promptly," the VA service center in Philadelphia wrote. "However, as we have a great number of claims, action on yours may be delayed."

The letter said the VA would contact the family if it needed more information, "so there is no need to contact us."

What it meant was: Things are going to slow down from here. Don't bother us. We'll get to you when we get to you.

Her father had a mental competency exam in July. In August 2008, a \$1,842 monthly pension was approved, retroactive to March. But the check wasn't in the mail.

Robert Dietrich failed the competency exam because of his poor health, which included dementia. Because the VA won't honor civilian powers of attorney, it wouldn't pay his daughter on his behalf. Instead, the VA planned to appoint a fiduciary -- a stranger -- to handle his money.

#### **CHECKS ON THE WAY FOR VETERANS**

CAPITAL REGION — Starting in June, Uncle Sam will give eligible veterans and their survivors a one-time payment of \$250 to help them through the recession, Sen. Kirsten Gillibrand, D-N.Y., announced on Friday.

# STUDY LINKS GULF WAR EXPOSURES, BRAIN CHANGES

A new study of veterans of the 1991 Gulf War suggests that exposure to neurotoxins such as anti-nerve agent pills, insect repellent and Sarin caused neurological changes to the brain.

However, brain imaging shows those changes appear to differ depending on what and how much each person was exposed to. The changes also correspond to different sets of symptoms.

Researchers at the University of Texas Southwestern Medical Center, Southern Methodist University, and the Veterans Affairs Medical Center in Dallas performed digital brain scans on 21 chronically ill Gulf War veterans from the same Naval Reserve construction battalion, all of whom had symptoms of "Gulf War syndrome."

# NATIONAL GUARD AND RESERVE ACTIVATED AS OF APRIL 7, 2009

This week the Army and Navy announced an increase, while the Air Force and Marine Corps announced a decrease. The Coast Guard number remained unchanged. The net collective result is 243 more reservists activated than last week. At any given time, services may activate some units and individuals while deactivating others, making it possible for these figures to either increase or decrease. The total number currently on active duty from the Army National Guard and Army Reserve is 99,329; Navy Reserve, 6,737; Air National Guard and Air Force Reserve, 14,201; Marine Corps Reserve, 7,482; and the Coast Guard Reserve, 666. This brings the total National Guard and Reserve personnel who have been activated to 128,415, including both units and individual augmentees.
