### LET'S STOP BLAMING THE TROOPS

We don't think that we are blaming them – after all aren't we doing nothing but praising them? Don't our politicians of all stripes praise them almost daily on the floor of an empty House and Senate? Let's take a step back.

Every day we hear statement after statement that in effect all say, "We can't leave Iraq because we will – [choose one of these, all taken from war supporters' statements in the last six months]

- 1. Destroy the morale of the troops by calling them losers
- 2. Tear down the military by declaring that the US has lost the war
- 3. Dishonor the memory of our soldiers' buddies who were killed fighting this war by leaving without winning, thus we will make all of those losses deaths in vain
- 4. Encourage the enemy and make our soldiers more vulnerable
- 5. Render our military forces unbelievable as a future deterrent

### And don't' forget!

6. Our brave boys and girls are fighting "them" over there so that we don't have to fight "them" over here.

Does everyone over the age of about 45 find these statements reminiscent of another time in our own history?

Let's take them one at a time.

- 1. No one is calling our troops "losers". The only "losers" are those who declared or agreed to unilateral war, won that war, and then proceeded to lose the peace. The troops are doing what they are sworn to do. They like "winning", but increasing numbers of them don't think that there is a "win" left.
- 2. The military has been "torn down" before and has recovered. Most of them understand that the politicians and bureaucrats will take credit for the "wins" and blame them for the "losses" anyway. Often the politicos are able to describe the same disaster as a win for them and a loss for the military.
- 3. This one frosts me. The tragic thing is that this statement seems to come most easily from those who have children in the fight. Ask just one soldier if he believes that he should die to honor the memory of his buddy who died last week.

I'll say it, and some won't like it – our kids <u>are</u> dying in vain They will not have died in vain because they pull out. They will not die in vain because the peace is lost. They are dying in vain

- because in the two meanings of that word they have been and continue to be sent in vain [i.e., on a fruitless mission] by an administration, Congress and a Pentagon that, because of thier own vanity [excessive pride], cowardice, and ignorance cannot admit that they made a monstrous mistake.
- 4. Again we can ask our soldiers if they think that their foe needs any encouragement. They seem to be pretty much encouraged already to continue the fight. There is nothing that we can say or do here that will make our soldiers more vulnerable than they already are with a fuzzy mission, no plan for disengagement, and a tactical scheme that makes new enemies every day.
- 5. Even if our forces were run out of Iraq on a rail they would never be looked upon as an unbelievable force in the future. No one is challenging the US militarily. Maybe once someone else wins the economic or the political challenge that we have been ignoring they will challenge us militarily, but instead we concentrate on the non-threat of military engagement, and ignore the real threat of economic and political defeat.
- 6. Even the Mahdr Army, all 30,000 of them, are not headed for Pittsburgh any time soon. If by this statement someone means that we will be subject to terrorist attacks in the future, I would have to answer, "Of course we will be; we have been under that threat for half a century at least." I would also ask, what are we doing specifically right now that will lessen that likelihood. We are growing terrorists by the thousands faster than we can kill them. Many of those we call terrorists are clearly described in current US military literature, not as terrorists, but as asymmetrical warriors. They are also described in treaty language as defenders of their own land and property. How is what we are doing today keeping a terrorist in Indonesia from deciding to blow up the Wal-Mart in Chillicothe. It is time for a "get real" moment, folks.

So, when we pop out these glib comments on why we should stay we are, in effect, saying, "We have to keep killing the troops in order to save the troops." That's only mildly different from, "We had to destroy the village to save it."

As for "winning":

"They don't have to win. All they have to do is not lose"

### **JUST ANOTHER STORY FROM ARLINGTON WEST**

Memorial Day being over, perhaps we don't need to hear another story about our men and women serving in Iraq. This weekend however, we had an active duty Marine visit the Arlington West display in Santa Barbara at the beach who related her personal experience to me. I thought others would be interested in her story. It is not special, only typical of the Iraq Veterans who come to find the name of a fallen comrade.

A young, very attractive girl, (I guess in her twenties) was introduced to me by her friend, a Viet Nam vet. He asked me to "Take care of her." We immediately bonded even though I was old enough to be her father, I believe because I had served during the Viet Nam era.

She wanted to find a name among the crosses. I found the name and she began to weep uncontrollably. I held her and asked her how she knew this female soldier. She replied that it had been her duty to send her out on patrol the night she was killed. She then asked for another name. I found it. She asked if it could be placed with the other soldier. I replied, "Of course" and asked her how she knew this soldier. She said he was returning from another assignment and stopped to talk to her friend when a suicide bomber detonated his device killing both soldiers. Again she lost all composure. I assured her that it was all right to cry as I had seen many male Marines cry just as hard. She then asked for another name. I found it and brought it to her. The cause of death said "killed in non-combat related incident." I asked her how he died. She replied, "He put a gun to his head and committed suicide." By this time, I could take no more and was in tears myself.

As a nation, we must become more cognizant of the heavy price we are paying for this fiasco in Iraq. It is our duty to question the decisions of our politicians because those who serve cannot.

Before leaving, this young lady informed me that she had just reenlisted for another four years. I told her I did not like that decision but would be proud of her if she were my own daughter. I fear for her as if she is my own daughter.

### TRYING TO AVOID DISENFRANCHISEMENT OF SERVICEMEMBERS IN THE EVENT OF A RUNOFF ELECTION

The California legislature is considering a bill, <u>AB 1662</u>, to provide each service member with a special runoff ballot which would allow them to state their preference for other candidates in addition to their own should a runoff occur in any office. This would be a good model for all states, especially those where service member ballots are ignored or sent so late that they cannot respond.

### APPARENTLY EVERYONE IS IN AGREEMENT

<u>BUSH SEES LONG-TERM ROLE FOR TROOPS</u> — They will serve as a deterrent to threats in Iraq, as they have done in South Korea.

### GATES, U.S. GENERAL BACK LONG IRAQ STAY - U.S. Presence Said to Reassure Allies

Gates told reporters in Hawaii that he is thinking of "a mutual agreement" with Iraq in which "some force of Americans . . . is present for a protracted period of time, but in ways that are protective of the sovereignty of the host government." ### WITH ALLIES IN ENEMY RANKS, GIS IN IRAQ ARE NO LONGER TRUE BELIEVERS

Staff Sergeant David Safstrom does not regret his previous tours in Iraq, not even a difficult second stint when two comrades were killed while trying to capture insurgents.

"In Mosul, in 2003, it felt like we were making the city a better place," he said. "There was no sectarian violence, Saddam was gone, we were tracking down the bad guys. It felt awesome."

But now on his third deployment in Iraq, he is no longer a believer in the mission. The pivotal moment came, he says, this past February when soldiers killed a man setting a roadside bomb. When they searched the bomber's body, they found identification showing him to be a sergeant in the Iraqi Army.

"I thought, 'What are we doing here? Why are we still here?' " said Safstrom, a member of Delta Company of the 1st Battalion, 325th Airborne Infantry, 82nd Airborne Division. "We're helping guys that are trying to kill us. We help them in the day. ### COMMANDERS SAY PUSH IN BAGHDAD IS SHORT OF GOAL

BAGHDAD, June 3 — Three months after the start of the Baghdad security plan that has added thousands of American and Iraqi troops to the capital, they control fewer than one-third of the city's neighborhoods, far short of the initial goal for the operation, according to some commanders and an internal military assessment.

The American assessment, completed in late May, found that American and Iraqi forces were able to "protect the population" and "maintain physical influence over" only 146 of the 457 Baghdad neighborhoods. ### MANY RETURN TO WAR; MANY NEVER GO

WASHINGTON - Even as troops in Iraq and Afghanistan are serving longer and more often - three, four, even five times - roughly half of Americans in uniform have not been sent at all. ... By this spring, roughly 150,000 active duty Soldiers, 85,000 Sailors, 90,000 Airmen and 65,000 Marines had gone more than once to Iraq, Afghanistan or surrounding countries. About half the total force had not deployed to either conflict, Defense Department figures show. Fifty-three percent of the active duty Air Force and 50 percent of the Navy had not been to the wars, not surprising since the fighting is overwhelmingly on the ground. ### MARINES FAIL TO GET GEAR TO TROOPS

WASHINGTON - The system for delivering badly needed gear to Marines in Iraq has failed to meet many urgent requests for equipment from troops in the field, according to an internal document obtained by The Associated Press. Of more than 100 requests from deployed Marine units between February 2006 and February 2007, less than 10 percent have been fulfilled, the document says. It blamed the bureaucracy and a "risk-averse" approach by acquisition officials.

ANCHORAGE, Alaska — About half of all National Guard equipment is being used in the Middle East, and the Guard's senior uniformed officer said Tuesday that could hurt the organization's overall readiness at home. National Guard units have 53 percent of the equipment they need to handle state emergencies, said Lt. General H. Steven Blum. It falls to 49 percent once Guard equipment needed for war — such as weapons — is factored in, he said.

### **NEW SCAM TARGETS MILITARY SPOUSES**

WASHINGTON, May 31, 2007 – The American Red Cross is warning military spouses about a new identity-theft scam that targets family members of deployed troops. The Red Cross was alerted of the scam earlier this month, said Devorah Goldburg of the Red Cross.

The scam involves a person with an American accent calling a military spouse, identifying herself as a representative of the Red Cross, and telling the spouse that her husband was hurt in Iraq and was medically evacuated to Germany. ### COURT OF APPEALS FOR VETERANS CLAIMS FACES INCREASED BACKLOG, JUDGE TESTIFIES AT HOUSE SUBCOMMITTEE HEARING

Thursday, May 24, 2007

A federal appeals court judge on Tuesday before the House Veterans' Affairs Subcommittee on Disability Assistance and Memorial Affairs testified that the U.S. Court of Appeals for Veterans Claims is averaging 300 appeals per month and facing a growing backlog, *CongressDaily* reports.

Judge William Greene, the court's chief judge, presented statistics to the subcommittee showing that his court is among the busiest of the federal appeals courts. The statistics showed that 2,542 new appeals were filed in the first six months of fiscal year 2007, compared with 3,729 for all of FY 2006. In addition, benefit denials by the Department of Veterans Affairs' Board of Veterans Appeals increased to 18,107 in FY 2006, almost double the number from two years earlier.

### BATTLING ON 2 FRONTS, MOTHER CHARGED AS AWOL

In a rare legal clash pitting a mother against the US military, Specialist Lisa Hayes of the New Hampshire National Guard surrendered yesterday to Army authorities after being charged as a deserter for refusing to fight in Iraq until a custody case involving her 7-year-old daughter was resolved.

The dispute, among the first of its kind in New England, underscores the tremendous strain the Iraq war has placed on the Guard and the nation's all-volunteer military, whose members often leave behind needy families and tumultuous personal lives as their combat tours are repeatedly extended. In February, Hayes received emergency leave from her second deployment to Iraq after an alleged domestic violence incident at her former husband's house, where her daughter, Brystal Knight, was staying. As the resulting custody case moved slowly through the courts, the military ordered her back to Iraq.

### NO RECORDS KEPT ON VETERANS' SUICIDES

WASHINGTON - In the three months after Marine Maj. John Ruocco returned from Iraq feeling numb and depressed, he couldn't sleep. He had lost weight. He had nightmares. He was distracted and withdrawn from his two young sons. One night, he promised his wife, Kim, that he would get help. The next morning, he was dead. The 40-year-old Cobra helicopter pilot, based at Camp Pendleton, Calif., had hanged himself.

There are others. Army reservist Joshua Omvig. Army Capt. Michael Pelkey. Marines Jonathan Schulze and Jeffrey Lucey. Each came home from tours in Iraq and committed suicide. ... Paul Rieckhoff, executive director and founder of Iraq and Afghanistan Veterans of America, says that although suicides among troops returning from the war is a significant problem, the scope is unknown.

"The problem that we face right now is that there's no method to track veterans coming home," said Rieckhoff, who served in Iraq as a platoon leader in the first year of the war. "There's no system. There's no national registry."

More than four years into the war, the government has little information on suicides among Iraq war veterans.

"We don't keep that data," said Karen Fedele, a VA spokeswoman in Washington. ### AT U.S. MILITARY HOSPITALS, 'EVERYBODY IS OVERWORKED'

FORT STEWART, Ga. — Winn Army Community Hospital has a baby boom it cannot handle. Mothers and children and strollers pack the pediatrics department, another hassle after long waits for hard-to-get appointments. The problems don't stop there. From gynecology to internal medicine, this hospital on the grounds of Fort Stewart, the biggest Army base in the South, is overwhelmed. Too many patients are demanding too many services from a medical facility with too few doctors and too little space.

Military families complain they can't get in to see a doctor. The hospital's top commander points to a lack of money and staff to meet basic needs. And everyone involved agonizes about whether the problems can be fixed any time soon.

The Army's acting surgeon general says the situation here illustrates the challenge the service faces nationwide in keeping health care promises that were made to soldiers when they enlisted. ### VA CUTS DOWN ON SGT. RYAN'S THERAPY

Ellenville [NY] — Veterans Affairs officials — facing a lifetime medical bill that could balloon to \$17 million — cut back yesterday on care for wounded Marine sniper Sqt. Eddie Ryan.

"They will never admit it, but we know it's about the money," said Chris Ryan, a former Marine who has become an outspoken supporter of his son and a critic of bureaucrats. The 23-year-old Marine was hit in the head by two bullets fired from an American tank in 2005.

Last week, five Albany VA officials surprised Angela Ryan, Eddie's mother, with a phone call. ### **HIGHER TRICARE FEES ENDORSED**

The Pentagon-appointed Task Force on the Future of Military Health will endorse higher TRICARE fees, deductibles and copayments for under-65 retirees and their families in an interim report to be sent to Congress May 31. It also will back other key features of the TRICARE "reform" package first proposed last year by the Department of Defense. These include:

- -- Raising beneficiary co-payments on prescriptions filled in the TRICARE retail pharmacy network.
- -- Indexing TRICARE fees and deductibles so that automatic annual adjustments keep them in step with rising healthcare costs.
- -- Establishing tiers for the new TRICARE fee structure, probably based on rank at retirement, so that retirees with bigger annuities pay more for their health care coverage and retirees with smaller annuities pay less.

### NATIONAL GUARD AND RESERVE MOBILIZED AS OF MAY 23, 2007

This week, the Army, Air Force and Marine Corps announced an increase, while the Navy and Coast Guard had a decrease. The net collective result is 1,985 more reservists mobilized than last week. At any given time, services may mobilize some units and individuals while demobilizing others, making it possible for these figures to either increase or decrease. Total number currently on active duty in support of the partial mobilization for the Army National Guard and Army Reserve is 66,169; Navy Reserve, 5,646; Air National Guard and Air Force Reserve, 6,025; Marine Corps Reserve, 5,414; and the Coast Guard Reserve, 364. This brings the total National Guard and Reserve personnel, who have been mobilized, to 83,618, including both units and individual augmentees. NOTE: There has been no release of this data since 23 May 2007

Armed units from the private security firm Blackwater USA opened fire in Baghdad streets twice in two days last week. It triggered a standoff between the security contractors and Iraqi forces, a reminder that the war in Iraq may be remembered mostly in our history books for empowering and building America's first modern mercenary army.

There are an estimated 20,000 to 30,000 armed security contractors working in Iraq, although there are no official figures and some estimates run much higher. Security contractors are not counted as part of the coalition forces. When the number of private mercenary fighters is added to other civilian military "contractors" who carry out logistical support activities such as food preparation, the number rises to about 126,000.

"We got 126,000 contractors over there, some of them making more than the secretary of defense," said House defense appropriations subcommittee Chairman John Murtha (D., Pa.). "How in the hell do you justify that?"

The privatization of war hands an incentive to American corporations, many with tremendous political clout, to keep us mired down in Iraq. But even more disturbing is the steady rise of this modern Praetorian Guard. The Praetorian Guard in ancient Rome was a paramilitary force that defied legal constraints, made violence part of the political discourse, and eventually plunged the Roman Republic into tyranny and despotism. Despotic movements need paramilitary forces that operate outside the law, forces that sow fear among potential opponents, and are capable of physically silencing those branded by their leaders as traitors. And in the wrong hands, a Blackwater could well become that force.

American taxpayers have so far handed a staggering \$4 billion to "armed security" companies in Iraq such as Blackwater, according to House Oversight and Government Reform Committee Chairman Rep. Henry Waxman (D., Calif.). Tens of billions more have been paid to companies that provide logistical support. Rep. Jan Schakowsky (D., Ill.) of the House Intelligence Committee estimates that 40 cents of every dollar spent on the occupation has gone to war contractors. It is unlikely that any of these corporations will push for an early withdrawal. The profits are too lucrative.

Mercenary forces like Blackwater operate beyond civilian and military law. They are covered by a 2004 edict passed by American occupation authorities in Iraq that immunizes all civilian contractors in Iraq from prosecution.

### WOMAN'S SIGN MEMORIALIZES THOSE LOST IN IRAQ

DURHAM, N.C. -- One Durham woman says she honors veterans who pay the ultimate price everyday, not just on Memorial Day.

The war in Iraq started in 2003 and she started keeping a running tally of soldiers killed in Iraq two years later. NBC17 interviewed Beth Berman last year and today, one year later we once again met with the Durham resident to see how much the number has grown.

Around this time last year the number outside Berman's home in Durham was at 2,464.

"I'm changing it now to 3,454," Berman said.

A year later, the number's up almost a thousand. Berman began her tally in 2005 to remind people about what's going on in Iraq.

"I think it's easy, fairly easy, for people to go about their daily lives and forget that others are making the sacrifice," Berman said.

And the number keeps rising.

"April and the month of may have been unusually high in the casualty numbers," Berman said.

That's why Berman is speaking out against the war with a sign. And for the most part she says she's received mostly positive feedback from neighbors -- even strangers. Berman lives across the street from George Watts Elementary School. Last year, Berman says a teacher came over and hugged her for what she's doing. That teacher had just lost a son in Iraq -- killed by a roadside bomb.

"I didn't think we should go to war there but this sign is a reminder of the cost and it's also to honor those who are paying the price," Berman said.

Berman says she'll keep the sign up until the war in Iraq ends but hopes that time comes before Memorial Day next year.

### REMEMBER THOSE LEFT BEHIND

Iraq-Afghanistan vets need help on many fronts

Memorial Day is an opportunity to honor all those Americans who have made the ultimate sacrifice in combat.

Today, in ceremonies across the country, people will pay tribute to those who have died serving their country, including the more than 3,800 troops who have been killed in Iraq and Afghanistan.

For many, this will be a rare moment for real reflection on the human cost of this war.

Even after four years, the lives of most Americans have gone on unchanged. Fewer than 1 percent have served in Iraq or Afghanistan. But for the families of the fallen, and for the tens of thousands of wounded troops, the sacrifices are never forgotten.

I served for a year in Iraq with the 3/124th Infantry of the Florida National Guard, and had the privilege of leading 38 heroes in combat in Baghdad.

As founder of Iraq and Afghanistan Veterans of America, I am honored to know mothers of fallen soldiers who send care packages daily to their sons' fellow troops, and severely wounded Marines who have run marathons in the name of their fallen comrades.

For these brave Americans, every day is Memorial Day. But the rest of Americans can honor these heroes as well.

Learn about the issues facing troops and military families.

Over 11,000 troops have been wounded by roadside bombs. Tens of thousands have sought treatment for Post-Traumatic Stress Disorder and other mental health problems. Many can't afford to pay for college when they return from combat.

Some 15 percent of young Iraq veterans are unemployed. And, perhaps most shockingly, up to 300,000 troops suffer from undiagnosed brain injuries.

Talk to your children about the war. Point to Iraq on a map and explain that U.S. troops are serving there, that there are children living in Baghdad just like your family lives in Palm Bay or Titusville or Cocoa Beach.

Take young ones to a local VA hospital to say thank you to a veteran or deliver a note or homemade card. Teaching the next generation to appreciate and take seriously the sacrifices of men and women in uniform is a tremendous gift to the people currently serving our country.

Find about some of the worthy charities you can help. They include the Fisher House, which houses the families of hospitalized troops, and the Bob Woodruff Family Fund, which supports those with traumatic brain injuries.

Donate your time at hundreds of understaffed veterans' hospitals across the country. Or help disabled veterans transition to civilian life by making sure your company posts its jobs at HireVetsFirst.gov.

There are just a few of the thousands of ways to get involved. But no matter how you can help, please take time to show your support to troops and military families this Memorial Day.

The best possible tribute we can give to those who did not come home from war is to care for the families and fellow troops they left behind.
