SACRIFICE

We just passed the third anniversary of the Iraq War. We may have lost sight of the fact that the Afghanistan War has been going on for 17 months longer. If you mark the beginning of the US involvement in WW II, the Afghan War has gone on 8 months longer than US involvement in WW II, and in just 9 months, the Iraq War will have lasted as long.

[Memories of a 70-year old] In December 1944, the 3rd anniversary of that war, your car had an "A" stamp (probably) if your Dad hadn't put it up on blocks for "the duration". Your mother had those red and blue tokens and rationing chits to cover purchase of meat, canned goods, and sugar.

We were down to one pair of dress shoes a year in 1944, because the leather had to go to soldier's boots and other military gear. Forget tires for the buggy – there weren't any. We bought savings stamps (10¢ each) and \$25 dollar war/victory/savings bonds (the name changed as the war progressed favorably).

Our allies, the Brits, were in their 5th year of rationing, and it would go on for them for years more.

"Hey buddy! Don't you know there's a war on?"

RECRUITING

Is anyone confused about the latest reporting on recruiting? I was until I started looking into it. It is hard to get your hands on a single table showing goals and results; the services seem to be hiding these figures deeper and deeper.

Despite stories from individual recruiters (unnamed) and from the press (unattributed) that things are not going well, the official position is that all is going swimmingly and we are making and breaking records.

Interesting bit of information though. They may be making their goals, but, in a time when the services are stretched impossibly thin, they are lowering the total goals every year, and switching more to the Army each year. Since 2003, when

they lowered the goals mid- year to ameliorate their failure, the goals for the active force have been going down. The Reserve/Guard forces are not meeting their goals, partly because the goals there have been gradually going up, reflecting present and future dependency on non-regular forces. <See table at the end of this issue>

They have also switched the per-month goals to lower the numbers in the beginning of the FY far more than normal, to show early success, I guess. So far in FY 2006 (1st 5 months) they have acquired new recruits at a rate that will meet only about 78% of annual goals. Don't know what they are going to do if the summer months don't play out the way they hope. After 42% of FY 2006, they have attained 33% of their FY goals.

So they crow that the active force and reserve are meeting the numbers – on lowered expectations – and lament that the Guard is still missing their numbers – as they quietly and steadily raise their expectations. FYI – a California legislative staffer recently told me that the CANG is losing 300 currently active members for every 200 they recruit. Doesn't sound good to me!

I guess it's kind of easy for the DoD masters to move the numbers around, though. It makes the active and reserve force look good (which helps them build their careers), and makes the state-run Guard look bad - again. Why should they care anyway? They aren't their kids.

Once again we call on Paul Rieckhoff to state our case. Thanks Paul. [Ed.]

"There's almost a total and complete disconnect in this country," he said. "If you walk around in the streets today -- in Manhattan or in Newark or in Trenton -- it doesn't feel or look like a country at war and that's not a pro-war or anti-war statement.

It's about having a healthy public that's connected to the cost of war and what's going on. This is not George Bush's war. It's not the Republicans' war. It's America's war."

EVANS, BERKLEY INTRODUCE LEGISLATION TO ALLOW VETERANS A CHOICE IN REPRESENTATION

March 9, 2006

Washington, DC – Congressman Lane Evans of Illinois, Ranking Democrat on the House Veterans' Affairs Committee and Congresswoman Shelley Berkley of Nevada, Ranking Democratic Member on the Committee's Subcommittee on Disability Assistance and Memorial Affairs, today introduced a bill (H.R. 4914) that would permit veterans to hire an attorney when they disagree with a benefits claims decision of the Department of Veterans Affairs (VA). Currently, veterans are not allowed to hire

COMBAT VETERAN'S COMPENSATION, HOSPITAL FOOD

A bill that would guarantee a portion of retirement benefits to military members forced out of service because of combat injuries was introduced on Wednesday, March 8th. in the U.S. Senate.

The compensation bill would pro-rate retirement pay for injured veterans. Currently, service members who are injured before completing 20 years do not qualify for the benefit.

"People who had planned to make the military a career are being forced into premature retirement because of medical problems," said Sen. Harry Reid, D-Nev., the bill's sponsor. 1,000 MORE SAILORS EXPECTED TO JOIN GROUND FORCES IN IRAQ

Three years after Baghdad fell, the Navy is poised to dramatically increase the number of sailors in Iraq and Afghanistan, filling gaps in Army and Marine Corps units. THE top US military official has warned that Iraq is at a critical juncture and could devolve into civil war, amounting to perhaps his gloomiest assessment to date.

General Peter Pace, chairman of the Joint Chiefs of Staff, called Iraq "a place that is having some real difficulties right now" and said the country's direction probably would be determined by how it emerged from those difficulties.

His comments, in a speech to the Baltimore Council on Foreign Affairs on Monday, were a clear retreat from his statement a week ago that the war is "going very, very well".

IRAQ WAR VETERAN FIT FOR COMBAT, BUT NOT MAIL DELIVERY

HAMBURG, N.Y. -- Sgt. Jason Lyon underwent months of medical treatment after surviving a roadside bomb that killed three friends. It was an experience he said he never expects to forget.

But it is a relatively minor mishap that occurred six months earlier _ an ankle sprain suffered jumping off a Humvee _ that is proving difficult to move on from.

While military doctors have certified the National Guardsman as physically fit to return to combat if needed, the U.S. Postal Service says the ankle injury has left Lyon physically unfit to deliver mail.

"To me, it really seems unfair," said Lyon, who was recently turned down for a postal carrier job because of the 2004 injury. "The military says I can go to combat. I can march, run, fight in a war and do anything else a soldier can do. But the Postal Service says I'm not fit to deliver letters."

Lyon, 28, has a thick stack of medical reports from the Army declaring him fit for military duty.

"Currently no limitations of military or civilian activity," a National Guard medical officer wrote in a report on Lyon last month.

U.S. LACKS MECHANISM TO ACCURATELY TRACK TROOPS WOUNDED IN IRAQ Lorraine Ash - Cherry Hill Courier Post - Cherry Hill, - Mar 20, 2006

There is no disputing the number of American troops who have died in the war on terror. At press time, more than 2,590 soldiers had lost their lives, according to U.S. Department of Defense numbers.

But the number of wounded is not clear-cut. In fact, that count is elusive. DoD numbers have tallied 17,702 wounded.

"Basically, that's everybody who has been through the major military hospitals, like Walter Reed Army Medical Center," said Kryn Westhoven, spokesman for the New Jersey Department of Military and Veterans Affairs. "There are some who are not counted in that roll-up, and the numbers are not broken down by state."

New Jersey Gov. Jon S. Corzine has asked the department to track the number but the task is "nightmarish," according to Westhoven, particularly since the federal Health Insurance Portability and Accountability Act (known as HIPAA) does not allow patients' medical information to be reported because of privacy issues. HIPAA covers both the civilian and military populations.

"Let's say a soldier comes back and he's the walking wounded. He just needs physical therapy, but he is nonetheless wounded," Westhoven said. "Let's say he comes back to Fort Dix. He might go to a local doctor for two to three months for physical therapy and then be on his way. He might receive a 10 percent disability. He might have no disability. He might be fine afterwards. The point is, he'll never truly be tracked."

When Michael White, a database/Web designer for a Georgia cell phone company, heard conflicting news reports about casualties in Iraq, it bothered him enough to create www.icasualties.org, a Web site that has become a national reference point for war statistics. EFFECTS OF IRAQ WAR VARY DRAMATICALLY IN USA

After three years, the Iraq war has not hit the American pocketbook, diet or routine as much as the American psyche. It has changed what we do less than how we feel.

And many of us feel like crying.

The wages of war — roadside bombings, military funerals, shattered mosques, wounded children — have shaken people far from the violence.

Jackie Sanders, a 58-year-old widow who works at the Wal-Mart in Prairie du Chien, Wis., notices "a general sense of foreboding. People cry easily. The tears are right there, all the time."

Half of those interviewed in the latest USA TODAY/CNN/Gallup Poll say the war has made them cry, and almost nine in 10 say it has made them pray. Yet never in U.S. history has such a huge military effort — it has cost \$150 million a day, more than 2,300 American lives and more than 17,000 U.S. wounded — required so little of so many.

Unlike wars past, Americans don't have to pay higher taxes, burn less gas or eat less sugar. Their government has neither drafted them nor told them what to say or publish. There's nothing like the air raid drills of the Cold War or the mass street protests of Vietnam.

To some on the home front, it hardly seems like wartime at all.

VA DATA SHOW SIGNIFICANT INCREASE IN MEDICAL NEEDS OF RETURNING VETERANS

March 14, 2006

One in three receive an initial mental health diagnosis

Washington, D.C. – New data from the Department of Veterans Affairs (VA) are "strong proof" that the Administration's budget is insufficient to meet the mental health care needs of veterans returning from the wars in Iraq and Afghanistan. That is the conclusion of Illinois Rep. Lane Evans, Ranking Democratic Member of the House Veterans' Affairs Committee, and Maine Rep. Michael Michaud, Ranking Democratic Member of the Committee's Subcommittee on Health.

Evans and Michaud had requested the data, which showed that in the first three months of FY 2006, VA saw a 21% increase in the number of veterans from Operations Iraqi and Enduring Freedom (OIF/OEF) who have sought care at the VA. The department has seen 144,424 returning veterans through the first quarter of FY 2006, 33,858 more than the Administration had estimated in its budget proposal for the entire year.

According to information VA provided to the congressmen, nearly one in three of the veterans seen have had a VA hospitalization or outpatient visit due to an initial diagnosis of a mental health disorder. VA's numbers are consistent with a recent Army study that found that one in three soldiers and Marines who have served in Iraq sought mental health care services.

SOLDIER FEELS ABANDONED IN HIS COURTROOM BATTLE

Army Has Refused to Allow Testimony to Aid Case

Cpl. Kendall D. McKibben was prepared to sacrifice his life for the Army. He says he almost did repeatedly over a year of patrols dodging bullets in Baghdad and dealing with a grape-size brain tumor. So the 33-year-old says he can't understand why the military is refusing a routine subpoena that he believes could help him avoid a 13-year prison sentence.

McKibben goes on trial today in Howard County District Court on charges of assaulting a police officer during what he and his doctors believe was an epileptic seizure related to his now-removed brain tumor. But military officials will not allow his doctors to testify. ... Gergely said the doctors could help win an acquittal for McKibben by showing that he had suffered a seizure during the assault and therefore should not be held responsible for his actions.

Ann Johnson, a spokeswoman for Walter Reed, said the policy restricting testimony of military staff is designed to limit "the loss of duty time by Army personnel" and "to include strict impartiality where the Army does not have an interest in the litigation." Or, as an attorney-adviser at Walter Reed Army Medical Center wrote in a Dec. 19 letter to Gergely: "Our sole concern in this matter is to protect the interests of the United States Army."

SENATE RESTORES \$3 BILLION TO DEFENSE BUDGET

Plan to raise veterans' health care fees also axed

The Senate voted Tuesday to restore \$3 billion that was cut from the defense budget by the Senate Budget Committee and to reject a Bush administration plan to increase health care fees for veterans.

The votes came as the Senate worked on SConRes 83, the congressional budget resolution that sets broad federal spending and revenue guidelines. The House does not plan to write its version of the bill until the week of March 27 at the earliest.

By a 100-0 vote, the Senate approved an amendment offered by Sen. Conrad Burns, R-Mont., that adds money to the Department of Veterans' Affairs health care budget to cover the money the Bush administration proposed to raise by increasing prescription drug co-payments and creating an enrollment fee for some veterans.

The amendment adds \$795 million to the veterans' budget to cover the fees, plus \$27 million for prosthetic limb research, which the Bush administration proposed cutting.

"These fees are not what we promised our military folks when they went off to war or when they stand ready to defend this country," Burns said. <More at: www.armytimes.com/story.php?f=1-292925-1599042.php>

SOME TROOPS HEADED BACK TO IRAQ ARE MENTALLY ILL

Besides bringing antibiotics and painkillers, military personnel nationwide are heading back to Iraq with a cache of anti-depressant and anti-anxiety medications.

The psychotropic drugs are a bow to a little-discussed truth fraught with implications: Mentally ill service members are being returned to combat.

The redeployments are legal, and the service members are often eager to go. But veterans groups, lawmakers and mental-health professionals fear that the practice lacks adequate civilian oversight. They also worry that such redeployments are becoming more frequent as multiple combat tours become the norm and traumatized service members are retained out of loyalty or wartime pressures to maintain troop numbers.

AILING VETS OVERWHELM SYSTEM

WASHINGTON -- At Ground Zero in lower Manhattan, Larry Provost said, he spent a week digging through the still-smoldering pile for survivors who weren't there.

His Army Reserve unit touched down in Afghanistan a year to the day after the Sept. 11, 2001 attacks. Then it was onto Iraq a year later, where every trip off base could be deadly, and Provost knew three fellow soldiers who died in a Baghdad roadside bomb attack.

It's why back home he swerves to avoid a piece of trash in the road, or tries to avoid large crowds -- things that would have been danger signs in Iraq, a hiding place for a bomb, or a bomber. Some experiences, he just can't forget, no matter how hard he tries.

But when he sought counseling at a Veterans Affairs hospital near his home in Virginia Beach, Va., he said he felt like the message was, "Take a number." He said he's been waiting several weeks for a counseling appointment and was told by one doctor it could be two months before getting in.

"I say to them, 'Why?' And they say back to me that 'Unfortunately, it's because of all you guys coming back, and we just can't handle you. It's nothing personal. It's just the way it is," Provost, 27, recalled.

BENCHMARKS: US IRAQ CASUALTIES STAY HIGH

Washington - As Iraq teeters on - or over - the brink of civil war the pressure is not easing on the hard-pressed U.S. ground forces there.

Over the past month, the average rate at which U.S. troops have been killed in Iraq has significantly fallen, but the rates at which they are being wounded have dramatically increased. ...in the 39 days from Feb. 11 through March 21, 616 U.S. soldiers were injured in Iraq, an average of 15.8 per day. This was more than twice as bad as the Feb. 4-10 period when 47 U.S. soldiers were injured at an average rate of just under seven per day. And it was also more than 36 percent worse than the rate of the five-day period from Jan. 30 through Feb. 3 when 58 U.S. soldiers were injured, according to the DOD figures, at an average rate of 11.6 per day. SEVENTH IRAQ WAR VETERAN KILLS HIMSELF

A Colorado-based Army Special Forces soldier back from Iraq shot himself in the head in his front yard Sunday night, according to police -- at least the seventh soldier who has committed suicide after serving there.

William Howell, 36, shot himself after following his wife around the yard with a handgun, according to the El Paso County Sheriff's Office. Howell served with the 10th Special Forces group in Iraq and returned to Fort Carson last month, according to the Army.

Another soldier who was attached to that unit in Iraq, Staff Sgt. Georg-Andreas Pogany, has claimed that the 10th Special Forces Group ignored him when he sought help with mental problems there, and then charged him with cowardice instead. Pogany, 32, also says the Army is ignoring the side effects of an anti-malaria drug called Lariam he took with the Special Forces, which has been linked to mental problems, aggression and suicides.

NATIONAL GUARD (IN FEDERAL STATUS) AND RESERVE MOBILIZED AS OF MARCH 15, 2006

This week, the Air Force and Navy announced an increase in the number of reservists on active duty in support of the partial mobilization, while the Army, Marine Corps and Coast Guard numbers decreased. The net collective result is 1,446 fewer reservists mobilized than last week.

At any given time, services may mobilize some units and individuals while demobilizing others, making it possible for these figures to either increase or decrease. Total number currently on active duty in support of the partial mobilization for the Army National Guard and Army Reserve is 97,593; Navy Reserve, 5,426; Air National Guard and Air Force Reserve, 7,646; Marine Corps Reserve, 6,916; and the Coast Guard Reserve, 407. This brings the total National Guard and Reserve personnel, who have been mobilized, to 117,988, including both units and individual augmentees.
