# FIRST CALL - THEME OF THE ISSUE AND/OR CLIPS & QUOTES

#### COBRA II

In a departure from the norm, I want to devote the editorial space in this issue to a book report. I haven't written one of these in decades, but there is a new book that demands it.

**Cobra II** is the book by Mike Gordon, New York Times military correspondent, and retired marine <u>Lt. Gen Bernie Trainor</u>, who retired as DCS Plans, Policies and Operations of the JCS.

If you read no other book on the Iraq War, this 500-page page-turner is the one you must read. The authors don't discuss the decision to go to war, so it doesn't matter what your opinion on that subject is.

What they do discuss in exquisitely referenced detail is the planning and implementation of the war. The first 175 pages discuss the lead up to the war, the next 290 the conduct of the war on the ground, and the last 140 the aftermath and the consequences, mostly bad, of decisions made and un-made in the first two phases. The maps are inadequate, so I have included one at the end of this issue that has enough detail to follow the story.

The heroes of the piece are not the Generals you have heard of, rather they are the ones who tried to make the best of an increasingly difficult situation and the, Colonels and the Lt. Colonels who commanded the brigades and battalions.

Long before the war began or was even contemplated by the administration, Gen Zinni had put in place a contingency plan for that area of the world. In developing that plan, he and his staff had become experts on the region. The plan called for up to 450,000 troops, not including Iraqis who would also serve.

Long before the war began, the US Army, most recently under Gen Shinseki, had been transforming itself into a lighter and more capable force, yet, its plans for a battle in that part of the world still called for 360,000 troops minimum, not so much to win the war, but to sustain the peace.

Both of these plans called for that many troops, <u>and</u> for the reconstitution of the Iraqi Army and Police Force in order to provide security and quality of life to the Iraqi people in the first moments after the war.

OSECDEF adopted the "transformation" title, but redefined it as a mostly high-tech, light infantry and armored cavalry charge up the middle – go, kick-ass, and leave within weeks. Worst of all it became an operational ideology not a plan for victory.

After the decision to go to war was made, and before the battle began, assumptions and decisions were made, among which were:

- 1. The real enemy was the Republican Guard
- 2. The only non-military opposition would be from diehard Baathist "dead-enders".
- Go with 3 Army, 1 Marine and 1 UK divisions: one through Turkey (4 ID), the others through Kuwait, with another division (1 Cav), supporting units and coalition forces following immediately
- 4. Attack early but not until the initial force is in place.
- Post-war would not require many troops to stay, maybe 30,000, because, other coalition troops and most of the 300,000-man Iraqi Army and the police would soon establish order because we would be greeted as liberators.

As the war progressed, all of these initial assumptions proved wrong and all of the decisions were undone- changed on the fly - yet OSECDEF and CENTCOM (Gen Franks) would not allow the battle plan or the aftermath plan to be changed.

For my money, the real hero of the war was Army LTG McKiernan, the ground forces commander for the war. As Washington cut troops, cut materiel, cut reinforcements (including halting the deployment of the 1<sup>st</sup> Cav), failed to open the northern front through Turkey, failed to enlist viable coalition military support, bypassed the JCS, bypassed McKiernan and went to subordinate commanders with direct orders, and in general, did for the Iraq War what McNamara did for the Viet Nam war, only faster - yet McKiernan rolled with every punch.

Gen Franks' own book *American Soldier* would have you believe that he practically pulled the war off by himself. This book will tell you who the real heroes and geniuses were who pulled it off against odds no fair government would ever impose on its soldiers.

By the time the initial battles were over on 1 May, a full fledged insurgency had been running since two days into the battle, with the Fedayeen being the real enemy, not the Republican Guard.

At that point, Garner was sacked, the US military high command was replaced *en masse* with Generals and staff with no Middle East experience. Bremer was brought in to set up the Coalition Provisional Authority, and the last of the decisions was undone when he promptly issued CPA Order #1 dissolving the Army and the Police, followed by CPA Order #2 dissolving three ministries, including Defense, and 23 other organizations. There was no government left; instead there were 300,000 angry, armed people on the street without money or work.

Get this book! Read it! You'll never find a better way to understand where we are today and why. [Ed.]

#### TIE DEFENSE BUDGET TO VA BUDGET

I have a simple idea that will appeal to both sides of the political aisle -- blue and red.

Today the Department of Defense's budget is a whopping \$455 billion; the Veteran's Affairs budget is about \$30 billion. These numbers speak for themselves (at least to me) but my idea will serve the general public and eliminate political pork-barrel bickering, nauseating debate and patriotic pretentiousness.

It's simple: Legally bind the DOD budget to the VA budget. Each time Congress raises the DOD budget, it simultaneously raises the VA budget by a fixed percentage or ratio. For example, DOD gets \$100, the VA gets \$15, or 15 percent.

First, we must level the playing field. I propose increasing the VA budget to 15 percent of the DOD budget or \$68 billion. From then on, any increase (including mid-year congressional appropriations to the DOD) is matched by a 15 percent contribution to the VA. The Iraq war is costing \$5 billion a month. Don't the casualties and the families of the actual warriors deserve the best medical support system they can get? All the veterans of all the past wars deserve better, too. So if the right side of the aisle wants a new SST fighter, then the left side of the aisle gets a couple arms and legs. Seems fair to me.

If it's all about money, which sadly, I believe this country has come to, let's put at least 15 percent of the war machine where it can do some human good.

## **\$160 MILLION IN EMERGENCY FUNDING WILL ALLOW THE VA TO PROVIDE** FREE CREDIT MONITORING SERVICES FOR AFFECTED VETERANS AND MILITARY PERSONNEL

Thursday, June 22, 2006

(WASHINGTON, D.C.) – U.S. Senator Patty Murray (D-Wash.) and Senator Robert Byrd (D-WV) today succeeded in passing emergency funding through the Senate Appropriations Committee to ensure that veterans healthcare and benefits are not raided as the Department of Veterans Affairs (VA) responds to last month's data security breach. The amendment passed 15-13 and garnered the support of two Republican members of the Committee.

... Murray, a senior member of the Senate Veterans' Affairs Committee and Byrd, the ranking Democrat on the Senate Appropriations Committee, are concerned that the VA will fund that program by cutting money from the VA's healthcare, benefits or information technology accounts.

..."It's not acceptable to tell veterans – 'We lost your personal information and by the way, we're going to cut your healthcare and benefits to pay for this mess that we created,' " Murray said.

### VETS HOUSING AND BENEFITS BILL BECOMES LAW

Senate Committee on Veterans' Affairs | June 16, 2006

Washington, DC - Legislation to help servicemembers and veterans with their housing and other benefit needs was signed into law Thursday, June 15 by President Bush.

"I am very pleased that this legislation, S. 1235, the <u>'Veterans' Housing Opportunity and Benefits Act of 2006</u>' was adopted with unanimous support in both the House and Senate," said the bill's sponsor, U.S. Senator Larry Craig, who chairs the U.S. Senate Committee on Veterans' Affairs.

"Provisions of this legislation will help improve the lives of servicemembers returning from the Global War on Terrorism, especially those who have severe disabilities."

Among its many provisions is one which authorizes <u>VA</u> to make grants available to assist with housing adaptations at a family member's home in which a severely disabled servicemember is temporarily residing. The grants range from between \$2,000 and \$14,000.

"Until today, severely disabled veterans had to own their own homes to qualify for adapted housing grant assistance from VA. But that doesn't make sense for many young men and women, some of whom may live with their parents after sustaining lifealtering injuries. #### MALIKI'S MASTER PLAN

A national reconciliation plan for Iraq calls for a timetable for withdrawal of US troops and, controversially, amnesty for insurgents who attacked American and Iraqi soldiers.

A timetable for withdrawal of occupation troops from Iraq. Amnesty for all insurgents who attacked US and Iraqi military targets. Release of all security detainees from US and Iraqi prisons. Compensation for victims of coalition military operations.

But they're also key clauses of a national reconciliation plan drafted by new Iraqi Prime Minister Nouri al-Maliki, who will unveil it Sunday. The provisions will spark sharp debate in Iraq - but the fiercest opposition is likely to come from Washington, which has opposed any talk of timetables, or of amnesty for insurgents who have attacked American soldiers. But in Iraq, even a senior military official in the US-led coalition said Friday that the coalition might consider a timetable under certain circumstances. And the official was careful to point out that a distinction needs to be made between terrorists and the resistance.

#### <u>'WASH POST' OBTAINS SHOCKING MEMO FROM U.S. EMBASSY IN BAGHDAD,</u> DETAILS INCREASING DANGER AND HARDSHIP

NEW YORK The Washington Post has obtained a cable, marked "sensitive," that it says show that just before President Bush left on a surprise trip last Monday to the Green Zone in Baghdad for an upbeat assessment of the situation there, "the U.S. Embassy in Iraq painted a starkly different portrait of increasing danger and hardship faced by its Iraqi employees."

This cable outlines, the Post reported Sunday, "the daily-worsening conditions for those who live outside the heavily guarded international zone: harassment, threats and the employees' constant fears that their neighbors will discover they work for the U.S. government." ...-- "Personal safety depends on good relations with the 'neighborhood' governments, who barricade streets and ward off outsiders. The central government, our staff says, is not relevant; even local mukhtars have been displaced or co-opted by militias. People no longer trust most neighbors."

# SENATE PASSES \$517 BILLION MILITARY BUDGET

The US Senate unanimously approved a 517.7 billion dollar defense bill for fiscal year 2007 that includes 50 billion dollars in funding for the wars in Iraq and Afghanistan. Passed on Thursday, the bill, which also includes a 2.2 percent pay raise for troops, will have to be reconciled with the House of Representatives' 427.6 billion dollar military budget passed Tuesday that also includes 50 billion for Iraq and Afghanistan. The US government's fiscal year 2007 starts October 1.

# CHER BACKS EFFORT TO MODIFY SOLDIERS' HELMETS

**NEW YORK (AP)** -- Cher, who opposes the war in Iraq but supports the troops, says using her celebrity to promote effective helmets for U.S. soldiers is rewarding -- and "the right thing to do."

"To be able to use your celebrity for something that you really think is worthwhile is so rewarding," the 60-year-old singer-actress says in an interview that was to air Wednesday night on CNN's "Anderson Cooper 360". "It just makes you feel like this is the right thing to do. This is the American thing to do," she tells Cooper.

# **U.S. MILITARY BRINGING EQUIPMENT HOME**

BALAD, Iraq -- The U.S. military has begun sending thousands of battered Humvees and other war-torn equipment home as more Iraqi units join the fight against insurgents and American units scheduled for Iraq duty have their orders canceled. In the last four months, the Army has tagged 7,000 Humvees and 17,000 other pieces of equipment to be shipped to the United States to be rebuilt. #### EUROPE SPENDING LESS ON MILITARY, US LEADS PACK

**STOCKHOLM**: Record overall military spending in 2005 masked divergent trends across the globe, with expenditure on the rise in the US and the Middle East but on the decline in Europe, the Stockholm International Peace Research Institute (SIPRI) said yesterday. The US remained the biggest worldwide spender with 48% of the \$1.118 tn pie and alone accounted for 80% of the \$33 bn increase in global spending, it said in its annual report.

... Europe was the only region with a decrease in military spending, by 1.7%, especially because of western European spending cuts. The biggest falls were recorded in Italy and Britain, SIPRI said.

Worldwide military spending represented 2.5% of gross domestic product (GDP) in 2005, or 173 dollars per capita. In China, spending was \$31.20 per capita, and in India, \$18.50. This compares to \$1,604 of military spending for each American, and \$1,430 for each Israeli, SIPRI said. [My emphasis – Ed.]

The 15 biggest spenders accounted for 84% of all expenditure. They are, in declining order, the US, Britain, France, Japan, China, Germany, Italy, Saudi Arabia, Russia, India, South Korea, Canada, Australia, Spain and Israel. </ doi: a to the second state of the se

**SYDNEY:** Prime Minister John Howard said yesterday the US was welcome to establish military bases in Australia. He was commenting on a report that two joint military training and "forward expeditionary bases" would be built in the north of the country.

"The notion of bases or operational facilities or training facilities by Americans is something I would warmly welcome," Howard said, without specifically confirming the report in the Australian Financial Review. "We made an announcement some time ago to the effect that we were going to expand the capacity for training and operations exercises in northern Australia for Americans," he said. "Whether you describe that as bases or not, I don't know."

...A new base at Bradshaw in the Northern Territory would be equipped with a landing strip for giant C-17 military transport aircraft and accommodation for some 750 troops, roughly the number in a US marine expeditionary battalion, the Financial Review said, quoting defence sources. This would give the US a major forward base to station and rotate troops and equipment for deployment to regional trouble spots. A base further south at Yampi Sound on the northwestern coast of Western Australia would host joint US-Australia training in amphibious seaborne landing techniques, the paper said.

#### DEADLY PRICE PAID FOR HUMVEE ARMOR USED TO PROTECT SOLDIERS

Sgt. Rene Knox Jr. of New Orleans was driving a heavily armored Humvee on a blackened dirt road near Balad, Iraq, when the vehicle rolled down an embankment and into a canal — killing Knox, two other soldiers and a serviceman trying to rescue them.

Three days later, Sgt. Timothy R. Osbey and Spc. Joseph A. Rahaim, National Guardsmen from Magnolia, Miss., drowned under nearly identical circumstances when their Humvee rolled over into a canal.

Twelve days later, Sgt. Julio E. Negron and Spc. Lizbeth Robles of Fort Carson, Colo., were killed and two others were injured after their armored Humvee hit the rear of another vehicle, throwing the two soldiers from the Humvee as it spun and then rolled twice.

None of the deaths was linked to combat.

The accidents are among 14 Humvee rollovers worldwide that killed nine soldiers and injured 18 in a 30-day period last year. In at least 13 of those accidents, the military Humvees were equipped with some additional armor intended to protect soldiers from injury, and nine of the vehicles were heavily armored with thousands of pounds of added weight.

"If there were two or three of these kinds of accidents (in the United States) on the same kind of vehicle because of a rollover, they would recall them all," said Debbie Newhouse of Glendale, Ariz., whose 21-year-old son, Nicholas Eugene Wilson, was killed in a rollover accident 11 days after the fatal crash involving Negron and Robles. "What the hell is the Army doing? What are they putting our kids into?"

# ARMY: 'ACTIVE PROTECTION' NEEDED ASAP

Army leadership has an obligation to soldiers in theater to field an active protection system as quickly as possible, even if it means getting out ahead of the Future Combat System (FCS), according to Gen. William Wallace, the head of Training and Doctrine Command. Wallace, who spoke with *Inside the Army* following a June 8 roundtable with reporters, said he did not think the development of an APS technology was mature enough, to date, to be integrated onto vehicles but said he believes the Army has an opportunity to move "very quickly" on fielding such a capability.

"I don't think we ought to wait until FCS for the active protection system if the technology proves itself of being worthy," Wallace [said]. "You know, it is one of those spiraling things. If we had a capability that matures quicker than the FCS [one] then we have an obligation to pull that stuff into the operational Army as quickly as we can and as quickly as we can afford it."

Although each APS system is unique, the basic principle behind the technology places a radar package on vehicles to detect an incoming rocket-propelled grenade. Once detected, the system engages the incoming round before it strikes the vehicle. </br>

#### **BODY ARMOR SAVES MARINES**

Habbaniyah, Iraq - The enemy snipers hit their targets- but it yielded them no results. In less than a week's time, Sgt. Joshua S. Adams and Pfc. Jason Hanson, of D Company, 3rd Light Armored Reconnaissance Battalion were hit by sniper shots. But the enemy had little effect because both were left with only minor injuries thanks to their small-arms protective inserts, or SAPI, plates.

While working in support of 3rd Battalion, 5th Marine Regiment, to complete counterinsurgency and humanitarian operations in the town of Habbaniyah, Hanson was the lead man on a patrol looking for roadside bombes on the main highway when a sniper shot him in the chest.

"I was checking my side and when I looked forward, I got shot -- it knocked me down," said Hanson, 21, a scout from Forks, Wash.

"I saw him on the ground, ran up to him and rolled him over," said the on-scene corpsman Seaman Chad T. Kenyon, 20, from Tucson, Ariz. "I saw that the round had gone through the front of his flak, so I opened up his flak and saw no bleeding. Then he looked up at me and said 'I'm fine, Doc."

The 7.62 mm bullet went through Hanson's rifle but was stopped by the Marine's SAPI plate, leaving him with some bruising on his chest. But it could have been a lot worse.

#### SOLDIER SUICIDES HINT AT MILITARY FAILURES

Army Spc. Jeffrey Henthorn, 25, of Choctaw, Okla., was sent back to Iraq for a second tour even though his superiors knew he had twice threatened suicide. He killed himself in 2005.

Army Pfc. David L. Potter, 22, of Johnson City, Tenn., was diagnosed with anxiety and depression while serving in Iraq in 2004. Records show Potter remained on active duty in Baghdad despite a suicide attempt and a psychiatrist's recommendation that he be separated from the Army. Ten days after the recommendation was signed, he slid a gun out from under another soldier's bed and shot himself.

These deaths are among the most extreme failures by the U.S. military to properly screen, treat and evacuate mentally unfit troops, a <u>Hartford Courant</u> investigation has found.

#### PTSD CARE DEMAND TAXING SYSTEM

Bangor Daily News | June 21, 2006

Thousands of veterans are returning from combat duty in Iraq and Afghanistan in need of mental health services, and concern is growing about the ability of the U.S. Department of Veterans Affairs to meet the demand. Over the past year, the number of veterans from Operation Iraqi Freedom and Operation Enduring Freedom diagnosed with post- traumatic stress disorder has more than doubled, increasing from a cumulative 9,688 by May 2005 to 25,317 by last month, according to a recent VA report.

U.S. Rep. Michael Michaud, D-Maine, on Monday expressed his concern that affected veterans will not be able to get the treatment and support they need to return to normal civilian life. "If the trend keeps up, by [Sept. 30] more than 30,000 servicemembers and veterans returning from Iraq and Afghanistan will seek mental health services at the VA due to an initial diagnosis of PTSD. # TAPS - PASSINGS AND WAR STATISTICS

#### NATIONAL GUARD AND RESERVE MOBILIZED AS OF JUNE 21, 2006

This week, the Army, Navy and Air Force announced an increase in the number of reservists on active duty in support of the partial mobilization, while the Marine Corps and Coast Guard numbers decreased. The net collective result is 740 more reservists mobilized than last week.

At any given time, services may mobilize some units and individuals while demobilizing others, making it possible for these figures to either increase or decrease. Total number currently on active duty in support of the partial mobilization for the Army National Guard and Army Reserve is 81,206; Navy Reserve, 4,847; Air National Guard and Air Force Reserve, 7,150; Marine Corps Reserve, 7,251; and the Coast Guard Reserve, 322. This brings the total National Guard and Reserve personnel, who have been mobilized, to 100,776, including both units and individual augmentees.


